Their Origin and Historical Development in their Economic and
Legal Aspect

This book shows that it is erroneous to regard syndicates, cartels and trusts, as different economic organizations, that they are merely different expressions of monopoly. Nor can they in any way be regarded as modern economic phenomena; they are only a contemporaneous expression of the monopoly movement which was well known in the markets of antiquity. Wherever competition arose there appeared its inseparable companion—monopoly, a movement which like free competition cannot be destroyed. This is clearly demonstrated by the history of the movement and the anti-monopolistic laws in particular countries from early antiquity till the end of the nineteenth century. The author sums up his historical survey with the suggestion that instead of making useless laws against monopoly which is inevitable, we should adopt a clear-sighted economic regulation of monopolistic organizations.
