Sarpanches to attend Independence Day Celebrations at the historic Red Fort tomorrow

Union Minister of Tribal Affairs, Shri Arjun Munda, hosted more than two hundred Sarpanches from Border Villages, under the Vibrant Villages Programme with their spouses at his official residence in New Delhi today. Those present on the occasion included Shri Atal Dullo, Secretary, Border Management, MHA; Shri Anil Jha, Secretary, Tribal Affairs and Shri Ashish Dayal Singh, Director General, Indo- Tibetan Border Police along with officers of Ministry of Tribal Affairs. The Government of India is prioritizing the development of the country's strategically important border areas. The guests have also been invited to attend the Independence Day celebrations at the iconic Red Fort, in the presence of the Prime Minister of India, Shri Narendra Modi.

The Vibrant Villages Programme (VVP) launched as a Centrally Sponsored Scheme, envisages comprehensive development of identified villages in 46 blocks abutting northern border in 19 districts of Arunachal Pradesh, Sikkim, Uttarakhand, UT of Ladakh and Himachal Pradesh.

Shri Arjun Munda, Union Minister of Tribal Affairs welcomed the guests as members of the family and remarked, "Tribals in border villages have protected the country since ages along with preservation of their local traditions and culture. They are the true patriots of the country. We are privileged to have you in our midst in the capital city. These border villages, once termed the 'Last Villages of India' have been termed the 'First Villages' by the Hon'ble Prime Minister of India, Shri Narendra Modi. India feels secure because the inhabitants of these border villages are keeping watch. Over 17 Ministers have visited and stayed overnight in these villages. Under the visionary guidance of the Hon'ble PM, the Government is trying to ensure the delivery of Government Programmes focusing on the Empowerment of women and youth, Connectivity with all-weather roads, provision of clean drinking water, 24x7 power to be focused on solar and wind energy, Mobile and Internet connectivity, Tourist centers, Multipurpose Center and Health and Wellness Center. Government schemes have enabled 13.5 crore people to break the shackles of poverty and join the new middle class: PM

The Prime Minister, Shri Narendra Modi, speaking from the ramparts of the Red Fort on the occasion of 77th Independence Day today, recalled that India has improved its world ranking from the 10th largest economy in 2014 to the 5th largest in 2023 today. The PM said that this rise happened due to fighting corruption, the stopping of leakages in transfer of government benefits and creation of a strong economy and spending of

public money for the welfare of the poor. "Today, I want to tell the countrymen that when the country is economically prosperous, it does not just fill the coffers; it builds the capability of the citizens and the nation. If there is a government that takes a pledge to spend this honestly for the welfare of its citizens, only then one achieves such rare progressive outcomes."

Transfer of funds from Centre to states up from Rs. 30 lakh crore to Rs. 100 lakh crore

Giving an account of the progress in the last 10 years, the PM said that the figures tell a compelling story of change. Asserting that the transformation is huge and a testament to the immense capability of the nation, the PM said that 10 years ago, 30 lakh crore rupees used to go to the states from the Government of India. In the last 9 years, this figure has reached 100 lakh crore, the PM pointed out. "Earlier, 70 thousand crore rupees were spent from the treasury of the Government of India for the development of local bodies, today it is more than 3 lakh crore rupees."

Four-fold increase in housing for poor, Rs. 10 lakh crore urea subsidy for farmers

The PM told the nation that earlier, 90 thousand crore rupees were spent to build the houses of the poor; today it has increased 4 times and more than 4 lakh crore rupees are being spent to build the houses of the poor. The PM informed that bags of urea which are sold at Rs. 3,000 in some global markets are being given to farmers at not more than 300 rupees. "The bags of urea that are sold for 3,000 rupees in some global markets, we provide to our farmers for 300 rupees, and hence the government is providing a subsidy of 10 lakh crore rupees on urea for our farmers."

MUDRA Yojana has enabled nearly 10 crore citizens to become job creators

The PM explained that the MUDRA Yojana has enabled crore of citizens to become entrepreneurs and thus also be job creators for others. "The Mudra Yojana, with a budget of over 20 lakh crore rupees, has provided opportunities for self-employment, businesses, and ventures for the youth of our country. About eight crore people have started new businesses, and it's not just eight crore people who started their businesses; each entrepreneur has provided employment to one or two individuals. The capability to provide employment to 8-10 crore new individuals has been achieved through the Mudra Yojana availed by eight crore citizens." The PM added that businesses too were supported during the COVID-19 pandemic, wherein MSMEs were supported with nearly 3.5 lakh crore rupees, preventing them from sinking and providing them strength.

The PM also recalled how the "One Rank One Pension" initiative brought the benefit of 70,000 crore rupees from India's treasury to our soldiers, as a tribute to them. The families of our retired soldiers have got this money, he said. The PM underlined that these are just a few examples and that there are many more initiatives that have significantly contributed to the country's development, generating employment in various corners of the nation. The PM reminded the nation that compared to earlier years, the nation's budget has been increased manifold across categories.

"13.5 crore people have broken the chains of poverty and entered the new middle class"

The PM informed that as a result of all these efforts, 13.5 crore poor people have broken free from the chains of poverty and entered the new middle class, during the one tenure of five years of the government. The PM told that there can be no greater satisfaction in life than this. The PM added that the various schemes ranging from housing schemes, provision of 50,000 crore rupees to street vendors through the PM SVANidhi scheme, and many more such schemes have aided these 13.5 crore people to rise above the hardships of poverty.

Dr Jitendra Singh calls for adoption of common terminology from English and other languages to promote the Indian Languages

Dr Jitendra Singh chairs the 14th Hindi Consultative Committee meeting attached to the Ministry of Personnel, Public Grievances and Pensions

It has been recently decided to conduct the government job test in 15 Indian languages so that the language barrier does not let any youth miss the job opportunity. This was stated in New Delhi today by the Union Minister of State (Independent Charge) Science & Technology; MoS PMO, Personnel, Public Grievances, Pensions, Atomic Energy and Space, while addressing the 14th Hindi Consultative Committee meeting attached to the Ministry of Personnel, Public Grievances and Pensions.

Notable progress has been made in the last more than nine years under the leadership of Prime Minister Shri Narendra Modi to promote the Indian regional languages besides the Official Language Hindi, he said. This historic decision will give impetus to participation of local youth and encourage regional languages, said the

Minister.In addition to Hindi and English, the question paper will be set in the 13 regional languages i.e. Assamese, Bengali, Gujarati, Marathi, Malayalam, Kannada, Tamil, Telugu, Odia, Urdu, Punjabi, Manipuri (also Meiti) and Konkani, he said. The decision will result in lakhs of aspirants taking part in the examination in their mother tongue/regional language and improve their selection prospects. Notable progress has been made in the last more than nine years under the leadership of Prime Minister Narendra Modi to promote the Indian regional languages besides the official Language Hindi, said Dr Jitendra Singh.

The DoPT Minister said there had been persistent demands from different States to hold SSC exams in languages other than English and Hindi. Government appointed an Expert Committee to look at this aspect too amongst other things (review of scheme and syllabus of examinations conducted by the Commission).

"Though the policy was initiated with the Official Language Rules, 1976, significant progress has been made only in the last five-six years," he said.Dr Jitendra Singh said the Staff Selection Commission recently unveiled the format for candidates to write their examination in 15 languages, plans are afoot to allow written tests in all 22 Scheduled Languages. The JEE, NEET and UGC exams are also being conducted in 12 of our languages.

"In UPSC, there is still a dearth of higher studies subject books but efforts are on in coordination with the HRD Ministry to promote specialized books in Indian languages. The first MBBS course in Hindi in the country was launched in October last year in Bhopal, Madhya Pradesh. And now Uttarakhand has become the second state to launch an MBBS programme in Hindi," he said. Calling for adoption of common terminology from English and other languages, Dr Jitendra Singh said Madhya Pradesh could take the lead in introducing medical education in Hindi by adopting words such as "nucleus" and "amoeba" verbatim rather than wasting time and resources in trying to cook up a translation.

Dr Jitendra Singh said the Prime Minister Shri Narendra Modi has taken a very historic decision in the new National Education Policy (NEP) by giving importance to the mother tongue of students in Primary, Technical and Medical education.

"PM Modi has given a call to provide Medical and Engineering education in regional languages such as Hindi, Tamil, Telugu, Malayalam, Gujarati, Bengali. Medical education has commenced in Hindi and soon Engineering studies will also begin in Hindi and translation of Engineering books has commenced in eight languages across the country, and soon students across the nation will be able to pursue Technical and Medical education in their mother tongue," he said.Dr Jitendra Singh said the Government introduced three pathbreaking bills in parliament during the recently concluded Monsoon session to replace the two centuries old criminal justice system, a legacy of the colonial era. "The Indian Penal Code, 1860 will be replaced by the Bharatiya Nyaya Sanhita Bill, 2023, the Criminal Procedure Code, 1898 will be replaced by the Bharatiya Nagarik Suraksha Sanhita Bill, 2023 and the Indian Evidence Act, 1872 will be replaced by the Bharatiya Sakshya Bill, 2023," he said.Dr Jitendra Singh said 56 of over 650 training modules of the Mission Karmayogi Prarambh under the Integrated Government Online Training (iGOT) portal have been made available in Hindi. Its scope may be widened to include other Indian Languages, he said.Calling for more frequent meetings of Hindi review committees in the Government Departments, Dr Jitendra Singh said, as we promote Hindi, other Indian Languages too would gain and prosper. "Real impact would be felt as the mindset changes, resulting in social change," he said.



On the occasion, Dr Jitendra Singh distributed awards and certificates of appreciation. He also released a book on freedom fighter Veer Savarkar by Dr K C Ajay Kumar, a member of the Hindi Consultative Committee and official publications of the Ministry. Members of the Consultative Committee and Members of Parliament, - Shri Satish Kumar Gautam and Shri Shyam Singh Yadav (both Lok Sabha) and Shri Rwngwra Narzary (Rajya Sabha) besides Hindi scholars participated in the deliberations. Secretary, Department of Administrative Reforms & Public Grievances, and Secretary, Department of Pension & Pensioners' Welfare, Shri V. Srinivas, Ms Deepti Umashankar, Establishment Officer & Additional Secretary, DoPT, and senior officers of the Ministry also attended the meeting.

Billed: Editorial on Modi government's bill to remove CJI from panel to select election commissioners

Symbolic diminution of power can't be without intent. The bill could be considered more dangerous than the undermining of all democratic or independent institutions during the present regime

The narrative continues without pause. Going by the policies and laws it formulates, the Narendra Modi-led government seems to have as its primary goal the concentration of all power in the hands of the Centre. With the appearance of responding to the Supreme Court order of March 2 that a selection committee for commissioners of the Election Commission should be formed, the government moved the chief election commissioner and other election commissioners (appointment, conditions of service and term of office) bill, 2023, that would establish the executive as the sole selector by law. The Supreme Court had formed an interim panel with the prime minister, the leader of the Opposition in the Lok Sabha and the Chief Justice of India, which would function till Parliament made a law; its emphasis was reportedly on making the selection objective and fair. Those who would take decisions regarding elections and ensure their conduct in a free and fair manner in a democracy are not expected to be selected by the government of the day alone. The bill,

however, complies with the requirement of making a law while ignoring the principle associated with the order which made the presence of the CJI logical. Mr Modi's government usually has a tense relationship with the Supreme Court; the bill takes it one — especially noticeable — step further by dropping the CJI from the proposed committee.

The bill is ominous. The committee shall consist of the prime minister, the leader of the Opposition and any Union minister of the prime minister's choice. Even this is not a particular chair, such as the law minister's. 'Choice' is extended to each of the commissioners. This would mean that the custom of the senior-most commissioner becoming the CEC would no longer operate, the government's preferences would. The picture is of an almost complete hijacking of the control of who runs the EC — the leader of the Opposition would be in a minority. Besides, the status of Election Commissioners has been equated with cabinet secretaries instead of Supreme Court judges. The symbolic diminution of power cannot be without intent. The bill could be considered more dangerous than the undermining of all democratic or independent institutions during the present regime. Its provisions reveal a possible goal — the people must decide whether it is their goal too.

New National Cooperative Policy almost ready: Suresh Prabhu

New National Cooperative Policy is nearing completion, and a committee of 47 members is currently finalising the draft to be submitted to the central government, said chairman of the panel and former Union minister Suresh Prabhu on Saturday. Union Home and Cooperation Minister Amit Shah had last year announced that a dedicated policy will soon be prepared to strengthen the cooperative movement in the country, and that Prabhu will head the national-level committee. The panel members include experts and representatives of the cooperative sector and officials of central ministries. "The policy document is almost ready and the submission process is underway. We can now look forward to the release of the policy and its

implementation," Prabhu told PTI on the sidelines of an event organised by the Merchants' Chamber of Commerce & Industry here.

According to Prabhu, the policy holds the capacity to transform India's socio-economic landscape by significantly increasing the share of cooperatives to the overall GDP. Prabhu highlighted that the policy's fundamental objective is to promote a cooperative-based economic development model backed by a legal and institutional framework.

"I have been connected with all types of national and international cooperatives for a long time, and know their potential. Any economic activity will add value to people's lives, but cooperatives help in spreading and distributing income while creating wealth." And, that is the reason the government is thinking of increasing the share of cooperatives in almost all sectors of the economy," he said. The existing National Policy on Cooperatives was formulated in 2002.

India has around 8.5 lakh cooperative societies with a member base of nearly 29 crore, according to government data. These cooperatives are engaged in varied activities like agro-processing, dairying, fisheries, housing, weaving, credit and marketing.

Prabhu, also a former railway minister, added that the cooperation ministry has decided upon creating cooperative warehousing as well.

"I think this is an amazing idea to further boost cooperatives. Millions of square metres of warehousing are being developed across the country," he added. In his Independence Day address, Prime Minister Narendra Modi said that cooperatives are a significant part of India's social economy, and that a separate ministry was created to empower cooperatives and spread their network.

The spirit of service

It is when you hear dedicated civil servants who entered the service not to wield power but to do good and serve the people that you realise how far away we have drifted from the idealism of that time. The earlier generation of civil servants and politicians must have done something good

I OFTEN feel that the last cruel joke the departing British played on us was granting us our independence in August, surely one of the cruellest months in this part of the world. And this year, thanks to the phenomenon called adhikmas (extra month) by our astrologers, the sultry, humid weather seems unending. Add to it this year's monsoon that has devastated large parts of north India, bringing floods and landslides every other day. The latest I see are parts of Punjab taking a hit, after Himachal and Uttarakhand have been battered relentlessly. Since I've already written about the human errors that have compounded the fury of nature and several experts have pointed this out already, there is little point in repeating those lessons that we never learn. However, these natural disasters can no longer be ignored. Wildfires raging across other parts of the developed world have not spared even those countries where the monsoon is not responsible for human and economic loss.

Independence Day celebrations are regarded as official torture by those who are compelled to attend them, sitting in the heat in front of the Red Fort ramparts and later, attending the President's At Home, in formal dress. The military top brass is the most pitiable lot in their starched uniforms and headgear. The others, in their formal bandgalas or suits with a mandatory necktie, are no better. Someone will have to think about this yearly punishment and perhaps have just flag-hoisting in the morning and the celebration at another time. I know this will never be acceptable but it's my concern for the audience who cannot sit at home to watch it on

their TVs that makes me suggest this. After all, the late Queen Elizabeth had two birthday celebrations: a private one at home and another one later when the weather was right for a parade and garden party.

Despite one's unwillingness to step out in this weather, some notable exceptions have to be made. Memorials, book events, landmark birthdays and anniversaries. This fortnight has had them all. Two of these book events were unmissable: one was my sister Mrinal's delightful book 'Sahela Re', written in Hindi and now translated into English. The discussion was one of the best I've heard in a long time but the highlight of the evening was an animated reading by the famed dastangoi artistes, Mahmood Farooqui and Darain Shahidi. Mahmood and Darain have revived this medieval genre to bring the magic of Urdu storytelling to modern audiences. They play to packed houses whenever they present a new dastan and have now inspired others, such as Sunil Mehra, to do their magic. If you ever get a chance to attend a performance, don't let it slip away. Persian literature is full of tales that were narrated by accomplished professional storytellers to those who could not read the classics. It is said that 'Arabian Nights', that fascinating cycle of stories and adventures, is a compilation of such stories. Akbar, a dyslexic who could not read, was lulled to sleep by a dastango each night, I gather. The art of animated narration has never lost its magic and whether a fractious, cranky child or an insomniac adult, a bedtime story soothes all restless people who find it difficult to relax.

The other book event was a panel discussion on Rajan Kashyap's memoir 'Beyond the Trappings of Power', which had an impressive panel of speakers: NN Vohra, Tejendra Khanna, Wajahat Habibullah and the author. It was delightful to run into several old friends and remember the days we spent together in Punjab and Chandigarh. I have yet to read the book but it is an addition to the many memoirs by Punjab-cadre friends and refreshes one's memories of those decades when Punjab was at the height of its glory, and then the later decades that were to see the worst days of terrorism and separatism. I am no longer in touch with the state and its present circumstances apart from what I gather from articles and books, so I cannot speak of what it is like now. What I hear and learn is disturbing, to say the least, and the kind of politicians that are now in charge

speak a language that I can no longer decipher. How much is truth and how much hype to build an individual leader is difficult to discern. This is as true of my own home state and the government in Delhi, so I cannot say that Punjab is worse than the others. However, when I look back at the deep attachment that we still have for the state and its people, the earlier generation of civil servants and politicians must have done something good.

This was brought out by all the panelists, each of whom rose to the highest echelons of power. From the aftermath of Partition, to the division of Punjab into three states and the creation of a new city, to the dark days of separatism and its handling — all these were vividly remembered and analysed. It is when you hear dedicated civil servants who entered the service not to wield power but to do good and serve the people that you realise how far away we have drifted from the idealism of that time. It is my fervent prayer that that spirit of service remains inviolate.

Government to open 25000 Jan Aushadhi Kendras to make medicines available at affordable prices

Number of Jan Dhan Accounts Cross 50 Crore

56% Accounts Belong To Women and 67% Accounts Opened In Rural / Semi-urban Areas

The national Mission on Financial Inclusion popularly known as Pradhan Mantri Jan Dhan Yojana (PMJDY) was launched on 28th august 2014 and it has completed almost 9 years. As per the latest reports submitted by banks the total number of Jan Dhan accounts have crossed 50 crore as on 9th August 2023. Out of these accounts 56% accounts belong to women and 67% accounts have been opened in Rural / Semi-urban areas. The deposits in these accounts are above Rs. 2.03 lakh crore and about 34 crore RuPay cards have been issued in these accounts free of cost. The average balance in PMJDY accounts is Rs. 4,076 and more than 5.5 crore PMJDY accounts are receiving DBT benefits.PMJDY scheme has been successful in changing the financial landscape of the country and has brought near saturation in bank accounts for adults. The success of PMJDY lies in the comprehensive nature of the scheme with an attempt to connect the last mile with the formal banking system through technology, collaboration and innovation.

PMJDY offers multiple advantages to account holders such as a bank account without requirement of minimum balance, free of cost RuPay debit cards with inbuilt accident insurance of Rs. 2 lakh and overdraft facility of up to Rs. 10,000.

Jan Dhan accounts cross 50 crore-mark in less than 9 years: Govt

The total number of Jan Dhan accounts in the country has crossed 50 crore-mark, with 56 per cent of the accounts belonging to women, the finance ministry said on Friday. About 67 per cent of these accounts have been opened in rural and semi-urban areas, it said in a statement. The total deposits in these accounts are above Rs 2.03 lakh crore while around 34 crore RuPay cards have been issued with these accounts free of cost.

The average balance in Pradhan Mantri Jan Dhan Yojana (PMJDY) accounts is Rs 4,076 and more than 5.5 crore of these are receiving Direct Benefit Transfer (DBT), it said. The National Mission on Financial Inclusion -- popularly known as PMJDY -- which was launched on August 28, 2014, has been successful in changing

the financial landscape of the country, it added.PMJDY offers multiple advantages to account holders such as a bank account without the requirement of a minimum balance, free of cost RuPay debit cards with in-built accident insurance of Rs 2 lakh, and an overdraft facility of up to Rs 10,000.

Government will adhere to fiscal deficit target of 5.9 pc for FY'24

The government will stick to the fiscal deficit target of 5.9 per cent of the GDP as robust tax, non-tax collections will help meet the spending requirement and make up for any shortfall in disinvestment proceeds, Finance Secretary T V Somanathan said on Friday. Although there would be a shortfall with respect to disinvestment, he said, this shortfall would be met by non-tax revenue mobilisation."Disinvestment target is unlikely to be met. However, I would say in aggregate the collective amount between disinvestment and nontax revenue is likely to be very close to the budget," he told PTI in an interview. The total of disinvestment receipts, plus non-tax receipts are likely to be very close to the Budget Estimates, he said."We expect to adhere to our fiscal deficit target this year...none of the events so far have caused anything for us to deviate from it," he said. The government has already got a higher dividend from the Reserve Bank of India and expects higher dividends from public sector banks and other PSUs than estimated in the Budget. The Reserve Bank of India in May approved a Rs 87,416 crore-dividend payout to the central government for 2022-23, nearly triple of what it paid in the previous year. The government was expecting Rs 48,000 crore from the RBI, public sector banks and financial institutions in the current fiscal. The dividend payout by the RBI was Rs 30,307 crore for the accounting year 2021-22. With public sector banks posting record profits of over Rs 1 lakh crore in fiscal 2022-23, the government's earnings from them are likely to be higher. Finance Minister Nirmala Sithartaman in the Budget stated that the fiscal deficit is estimated to be 5.9 per cent of GDP in BE 2023-24. To finance the fiscal deficit in 2023-24, the net market borrowings from dated securities are estimated at Rs 15.4 lakh crore.

In Budget Estimates 2023-24, the Finance Minister had that the total receipts other than borrowings and the total expenditure are estimated at Rs 27.2 lakh crore and Rs 45 lakh crore respectively. Moreover, the net tax receipts are estimated at Rs 23.3 lakh crore. Library is the temple of knowledge and even in this digital era, thousands of people depend solely on public libraries for knowledge gathering

Libraries symbolize the progress of civilization," Droupadi Murmu, President of India. Every year National Librarian's Day is celebrated commemorating the birth anniversary of Padmashri Dr. S. R. Ranganathan, the father of Library Science in India. He was the doyen of library science in India who developed the systematic classification of books, the colon classification and also penned the five laws of library science. The five laws he developed - Books are for use, Every reader, his book, Every book, its reader, Save the time of the reader; and A library is a growing organism, form the fundamental tenet of a library. Very often most of our librarians forget these principles and behave in an unwelcoming manner towards the readers.

They often forget that books are for the use of readers. This is more evident in libraries managed by schools, colleges and research institutions. The culture being followed in most of our schools and colleges is how to make students keep away from the readers. The books are locked safely in shelves and many poor books are awaiting a reader to touch its pages. Even in colleges accredited with very high ranks students are not allowed

free usage of the library. In libraries managed by research institutions, the situation is more pathetic. They will not entertain the public to utilize their facility or even if they allow there will be several do's and don't's, as if the reader is in a high-security area. Once there is a restriction no youngster will enter that zone further in his lifetime. Reading is a skill that can be nurtured only through active reading and librarians have a larger role to play. A good librarian is as good as a good encyclopaedia. A good librarian can bring attitudinal change in our youngsters. There are a few good librarians who keep interacting with the readers and inspiring them to read the new books available in the library. He should act as an agent for knowledge dissemination.

The library is a growing organism and its growth is possible only with the help of a good librarian. A good librarian should bring changes in the library culture that suites the present time. Even though the culture of silence should be maintained in the library, there should be allocated spaces for readers to make active discussions within the library. In some good libraries like IIM Trichy, there are even spaces where readers can lie down relax and read. Similarly in many libraries usage of laptops is restricted. Present day generation is more convenient in taking notes on their electronic devices rather than on paper. In most of the publicly supported libraries digital resources are also available, but in many cases, the users have to pay extra to use the computer system, even if they have a valid membership. The digital resources available in the library should be made accessible to all members even from their homes, as the British Council libraries are doing.

Library is the temple of knowledge and even in this digital era, thousands of people depend solely on public libraries for knowledge gathering. For students from economically marginalized sections, they are the sole resource material for the preparation of competitive examinations. Even though there are differences of opinion regarding the need for a physical library, the fact is that no digital library can replace the physical library in its role and function. Information in this era can indeed be gathered from our smartphones, but progress in human culture and civilization can happen only through libraries. The librarians of this generation

should not only act as facilitators in locating appropriate books but also act as facilitators in finding authentic resources from digital platforms.

A software solution for preventing attacks on 5G networks

A new indigenous software technology solution can now proactively detect and prevent zero-day vulnerability attacks in the 5G networks thereby reducing the network downtime. This can help smoothen countrywide communication as 5G networks become its lifeline in the near future. Around ninety percent of the 5G technology is implemented into software by integrating several latest technologies (NFV, SDN, control plane/user plane segregation) which enable testing the technology easily. But attack surface area is increased multifold in this process and is impossible to manage manually. Automating the whole testing process and continuous monitoring is the only sustainable solution. Currently majority of the run time zero-day vulnerabilities are identified post attack, thereby creating damage to the brand as well as increasing the cost of recovery.

IITM Pravartak Technologies Foundation at IIT Madras, a Technology Innovation Hub for Sensors, Networking, Actuators and Control Systems (SNACS), supported by the Department of Science and Technology (DST) under National Mission on Interdisciplinary Cyber Physical Systems (NM-ICPS), along with its incubated startup, is developing an indigenous security testing solution for 5G core network functions and Radio Access Network (RAN) software. This technology solution can automatically identify zero-day vulnerabilities in the network in advance by using techniques such as fuzzing and test oracles. This solution has been manually tested in the 5G security lab of IITM Pravartak. Since it can help avoid the attacks in advance, it protects organisations against loss and saving the credibility of the brands.

The team used ethical hacking for finding vulnerabilities in the system. They tested the functionality issue in the network, created various attack scenarios based on topology, feature interaction, and the number of nodes involved by following the defined 5G standards of 3GPP. The team is testing interoperability and security

issues with multi-vendor products. Tests are conducted at the network packet level, the binary level, the code level and also using the code vulnerability scanners. A combination of all these methods will help reducing zero-day attacks by pre-emption mechanism. Reducing zero-day vulnerabilities will reduce attack surface area, which in turn will reduce the need to pay ransom and also decrease network downtime of 5G networks which are crucial for communication.

Indian scientist develops novel method to improve accuracy and precision of nanomechanical testing technology

The new method enables faster testing of mechanical strength of extremely small volumes of materials for a wide range of fields from medicine to space

A novel method to test nanomechanical properties of materials at very minute scales with high precision and accuracy has been developed by an Indian scientist in collaboration with two international institutions. The new methodology not only significantly improves the precision and accuracy of what is known as nanoindentation technique or testing of mechanical strength, but enables testing at much higher rates, thus facilitating high throughput.

With Conventional testing methods not always feasible at nano scales, which are usually of the order of 1/100th of the diameter of a human hair, the nanoindentation technique was invented by Dr. Warren Oliver (KLA Corp.) and Dr. John Pethica (Oxford University) in the 80s and the analysis procedure was proposed by Dr. Warren Oliver and Dr. George Pharr (Texas A&M University) in their seminal work which had a huge impact on a broad spectrum of scientific research.

The technique has been widely used to measure the strength of semiconductor devices and structural materials that have ubiquitously penetrated every aspect of our daily life through electronic gadgets. The technique has been used for a wide range of applications from identifying cancerous cells to establishing how meteorites are formed in deep space.

In developing the new methodology, Dr. Sudharshan Phani of the Advanced Nanomechanical Characterization (ANC) Centre at Centre for Engineered Coatings, International Advanced Research Centre for Powder Metallurgy & New Materials (ARCI), Hyderabad, collaborated with Dr Warren Oliver at KLA and Prof. George Pharr of Texas A & M University. The novel approach involved a combination of extensive modeling and simulation to understand the material response during an indentation test and subsequent tailoring of the methodology to improve the precision and accuracy. The modeling results have also been validated by experiments under extreme conditions. Setting the tone for high precision and high accuracy nanoindentation measurements at much higher rates than what is traditionally possible, the new methodology is expected to impact a broad spectrum of scientific research on measuring the strength of materials at small scales. The details of methodology have been recently published in the prestigious journal in the field of materials science, 'Materials & Design'.

Dr Jitendra Singh expressed happiness that all the heads of the Scientific Department attended the Capacity Building meeting along with a large number of scientists joining online. The Minister exhorted the scientific community to pick up good things and best practices of the Corporate Sector. He also underlined that a threshold of absorption of capacity building must be defined.Dr Jitendra Singh informed that India is now launching cutting-edge technological breakthroughs in tandem with the Developed countries of the world and gave the example of the National Quantum Mission (NQM) and international laurels in the Space sector.

Consent Manager's role vital in data protection

The Digital Personal Data Protection Act, 2023 is being portrayed as the most revolutionary and awaited law for India. While it promises many protections, it also leaves many questions unanswered. One such issue pertains to the case of Consent Manager Framework introduced in DPDP Act, 2023. "Consent Manager Framework" was catalyzed by the recommendations of the report submitted to the Parliament visà-vis the Data Protection Bill, 2019. Consent Managers are third-party independent entities registered with the Data Protection Board They are responsible for managing, reviewing, and withdrawing the consent of the Data Principal by using a transparent platform. The Data Fiduciary is required to implement those processes to enable the Consent Managers to act on behalf of the Data Principal.

They will be operated within the paradigms of the electronic consent framework established by the Ministry of Electronics and Information Technology. The MeitY has released a set of technology standards for the purpose of electronic consent (wherein Consent Managers are referred as Consent Collectors). Section 2(g) specifies the definition of "Consent Manager" as a person registered with the Board, who acts as a single point of contact to enable a Data Principal to give, manage, review and withdraw her consent through an accessible, transparent and interoperable platform. A similar concept of Consent Managers was introduced by Reserve Bank of India in 2021. They are called "Account Aggregators." Like the Consent Manager, the prime job of AA is to obtain, submit and manage customer's consent via a technical legal framework that emphasises on the legality of sharing of consent like the Consent Managers do. Additionally, AAs accelerate the consented transfer of financial data between financial institutions such as Banks, Insurance Companies, Pension Funds etc.

The only difference is that AAs are acting as the Consent Manager in the financial sector. The objective of the act is to reinstate the concept of trust by safeguarding the personal information of the data principal and by imposing various lawful obligations on the Data processors and Data Fiduciary. "Consent," is the foundation of any privacy principle and data protection law. Given the diverse nature of the country, the operationalization of effective consent is required. Furthermore, the Consent Managers are thirdparty entities that use an interoperable tech framework to enable consent regulation digitally. A consent manager has the duty to act on the behalf of the Data Principal. They play a pivotal role in standardizing the consent. Organizations using this consent management framework find it quite feasible to adhere to the rights and regulations pertaining to the Data Principal and attract new clients and customers. The organizations are subject to numerous consent related responsibilities like permission to share, acknowledging the withdrawal of consent request, obtaining permission for the collection of data, obtaining informed consent for a specific objective and ability to showcase that the data was obtained before the handling of the data of Data Principals. To comply with the requirements for these standards, the organizations need to establish procedures and structures.

However, the correct practical answer will be provided by the Consent Manager who will follow a technolegal approach. The Consent Management Framework will provide the following: As the consent manager will construct the technical and legal standards as enumerated by the concerned authorities, so the organizations or companies who interlink their companies' systems with it will by default comply with the law. After the Data Principal gives consent for the sharing of data, the personal information shall flow directly from the original source to the one in need. This will assuredly avoid unauthorized collection of data from public sources, data scrapping etc. The trust of the user is at stake. However, once the authority approves the consent managers who will work under the set of guidelines such as openness, confidence, control and data reduction, this will surely be a win-win situation. Thus, the consent manager plays an important role in building the trust with clients as they are the only bridge between the Data Fiduciary and Data Principal. The

role of a Consent Manager within the DPDP Act can be seen as both a boon and a potential challenge, depending on the context and implementation. As a boon The consent taken from the Data Principal shall be specific, informed and unambiguous in nature along with clear affirmative action. A thoughtful Consent Manager shall simplify and streamline the consent provision process, making it more accessible for them.

A Consent Manager empowers individuals by bestowing them with enhanced transparency and control over their personal data which aligns harmoniously with DPDP Act's rights of the Data Principals. Consent Managers can serve as a mechanism for organizations to standardize their consent-related procedures, ensuring congruence with the Act. As a challenge In scenarios where Consent Managers are not appropriately implemented, there is a potential for organizations to misuse them as a means to manipulate or coerce users into granting consent without a full understanding of the implications. The incorporation of Consent Managers could potentially augment the compliance complexity, possibly creating challenges for organizations to seamlessly integrate, and for users to navigate.

Excessive consent requests without adequate information, or if consent becomes a mandatory prerequisite for availing services, may result in a situation where true, freely given consent is compromised. In conclusion, the Consent Manager Framework reflects that the DPDP Act, 2023 presents a transformative approach to data protection as it addresses the need for effective consent management in an evolving digital landscape. It is expected that the Consent Managers may act as intermediaries, facilitating transparent and controlled consent processes for Data Principals with the aim of restoring trust by safeguarding personal information and imposing legal obligations. However, the role of Consent Managers is two-fold. On the one hand, they enhance consent management by offering clarity, empowerment, and standardization. On the other, there's a risk of misuse and complexity if not implemented thoughtfully. While this framework symbolizes India's readiness to embrace the digital era by promising to protect the personal data of the citizens, it lacks the foolproof

mechanism in law vis-à-vis regulation of Consent Managers. One hopes that this issue will be expediently addressed for smooth implementation of the law.

Boost for artisans

Vishwakarma Yojana can provide a lifeline

THE approval by the Union Cabinet of the Rs 13,000-crore Vishwakarma Yojana is a much-needed boost for traditional craftspersons. Electoral considerations may have played a part in the announcement of the scheme in the run-up to the 2024 Lok Sabha elections; that said, extending help in any form to the traditional artisans is a highly laudable move. To be launched next month, the scheme covers 18 traditional trades across rural and urban areas. It aims to benefit about 30 lakh artisans and craftspersons, including weavers, goldsmiths, blacksmiths, laundry workers and barbers. Providing an opportunity to upgrade skill-sets, the promise of marketing support and the offer of collateral-free credit are welcome policy interventions.

The Centre plans to fund the scheme, but it will need the support of state governments. Without close coordination and a shared sense of purpose, the scheme could hit undesirable political hurdles. That must be avoided for the sake of artisans and the survival of traditional crafts. The younger generation does not find craft-making lucrative. Many are choosing not to carry forward the family legacy as they look for better job options. The increasing cost of raw material and the shift from handmade to factory-made products are the other challenges. In such a scenario, an institutionalised support system can be a lifeline for the struggling artisan families.

It's ironical that though the demand for curios for home décor is growing, the craftspersons are not reaping the benefits. Any plan targeted at their upliftment deserves all-round support. Equally praiseworthy is the Rajasthan Government's initiative to provide opportunities for artistes to perform for 100 days in their areas to encourage and preserve folk art.

The lotus named 'NBRI Namoh 108' is developed by the CSIR-National Botanical Research Institute (NBRI), a premier plant-based, multidisciplinary, state-of-the-art National R&D center based in Lucknow.

Dedicating to the nation the Namoh108 lotus variety and its products at NBRI, Lucknow, Dr Jitendra Singh said, "Considering the religious importance of the 'lotus flower' and 'the digit 108', this combination gives an important identity to this variety." The Namoh 108 lotus variety flowers from March to December and is rich in nutrients. This is the first lotus variety whose genome is completely sequenced for its characteristics.

Dr Jitendra Singh also released apparel made from lotus fibre and perfume 'Frotus', extracted from lotus flowers and developed by the NBRI under the Lotus Research Programme in collaboration with FFDC, Kannauj.Lauding the NBRI for naming the unique lotus variety as Namoh 108, Dr Jitendra Singh said it is a grand gift to the relentless zeal and innate beauty of Shri Narendra Modi, coming as it does in the tenth year of his tenure as the Prime Minister.



Also launching the Lotus Mission on the occasion, Dr Jitendra Singh said this project is being undertaken in Mission mode like the other priority schemes, - the National Honey and Bee Mission (NHBM), National Bamboo Mission (NBM), National Food Security Mission (NFSM), National Mission on Natural Farming (NMNF), National Mission for Sustainable Agriculture (NMSA), Gokul Mission, Blue Revolution, Mission Shakti - an integrated women empowerment programme and the National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS) etc. "Under the guidance of PM Modi, the Government has now initiated the Lotus Mission after the stupendous success of Aroma Mission. Dr Jitendra Singh also launched a Database of 500 Raw Drug Repositories of the Institute developed as per Indian Pharmacopoeia Standards and released a book on roses in CSIR-NBRI Garden, comprising the details of elite varieties conserved at the Botanic Garden. On the occasion, an MoU was signed between CSIR-NBRI & M/s Nucleome Informatics, Hyderabad for collaborative research on Cotton. The CSIR-NBRI digital Herbarium, a National Repository of flora specimens of India, was also launched to easily disseminate information among the public and a book on 'Plant Resources of Uttar Pradesh and a Check List' and 'e-flora of Uttar Pradesh' were also released. The e-flora and book provide a list and information of more than 5,000 plants of Uttar Pradesh. NHA and IRDAI jointly organized a workshop for Insurance Companies and TPAs for helping them complete integration with ABDM and National Health Claims Exchange (NHCX)

The three-day workshop saw participation by representatives from 45 insurance companies and Third-Party Administrators (TPAs)

The National Health Authority (NHA) and IRDAI (Insurance Regulatory and Development Authority of India) jointly organized an exclusive three-day Accelerator Workshop to help insurance companies complete their ABDM integration and to facilitate adoption of Health Claims Exchange (HCX) specifications and e-Claim standards for insurance companies and Third-Party Administrators (TPAs). The workshop was organized from 10th to 12th August 2023 in New Delhi and saw participation from over 150 professionals representing 29 insurance companies and 16 TPAs.

The IRDAI had issued a circular in June 2023 advising all insurance companies to start capturing ABHA (Ayushman Bharat Health Account) number of all of the persons seeking insurance cover and also to obtain their consent for sharing medical records with insurers/TPAs through ABHA. The ABHA number would help identify the insured in a digital environment and facilitate seamless healthcare and insurance service delivery. It would give insurers easy and timely access to a person's medical information in a safe and paperless manner and help the insured with a transparent and speedy process of claims servicing. Further, the IRDAI also issued a circular advising the insurers and providers get on-boarded to the National Health Claims Exchange (NHCX). The NHCX will serve as a gateway for exchanging claims-related information among stakeholders present in the healthcare and health insurance ecosystem including insurers, TPAs, claimants, beneficiaries,

healthcare providers etc. The integration with NHCX will enable seamless interoperability of health claims processing. More information on the NHCX is available here: https://sbxhcx.abdm.gov.in/

The combined efforts from the teams resulted in 29 entities, including 23 insurance companies and 6 TPAs completing their first level (M1) of ABDM integration, which enables them to create and verify ABHA. Further, 20 insurance companies were also able to successfully complete Level 1.2 of their NHCX integration which would enable them to link or delink ABHA with an insurance policy. Speaking about the outcomes from this workshop, CEO, NHA said – "This Accelerator Workshop was a first-of-its-kind focused initiative for ABDM adoption in the insurance sector. The large number of entities who got successfully integrated demonstrate the power of collaborative working to achieve a larger goal. This has definitely encouraged us to organize more such workshops to strengthen the digital health ecosystem."

NHA and CDAC, Pune provided technical support to the representatives from insurance companies and TPAs and helped them complete the respective integrations. The General Insurance Council (GIC) helped in bringing the concerned teams from leading insurers and providers for the workshop.

Chairman, Central Water Commission Launches Mobile App 'Floodwatch' To Provide Real-Time Flood Forecasts To Public Using Interactive Maps

The Chairman, Central Water Commission (CWC), Shri Kushvinder Vohra today launched the mobile application, "FloodWatch" with the aim of using mobile phones to disseminate information related to the flood situation and forecasts up to 7 days on a real-time basis to the public. The in-house developed user-friendly app has readable and audio broadcast and all the information is available in 2 languages, viz. English and Hindi. Key feature of the app includes real-time flood monitoring where users can check up-to-date flood situation throughout the country. The app utilizes near real-time river flow data from various sources. The app also provides flood forecast at nearest location where users can check the flood advisory at the station nearest to them on the Home Page itself.

Other key features include forecast using an Interactive Map where users can check the CWC Flood Forecast (up to 24 hours) or Flood Advisory (up to 7 days) either by directly selecting the station from map or the user can also search for the name of the station in the search box. The location will be zoomed in on the map when the name of the station will be selected from the dropdown. The app will also provide State-wise/Basin-wise Flood Forecast (up to 24 hours) or Flood Advisory (up to 7 days) which can be accessed by selecting specific stations, state wise or basin wise from the dropdown menu.

Addressing the gathering after launching the app, Shri Vohra said "we are delighted to introduce "FloodWatch," a mobile app that provides real-time flood situation in the country and flood forecasts to the public. The user-friendly app is available for download on Android devices, providing widespread accessibility to users globally. The app can be downloaded free of charge from the Google Play Store. The app will also be available on Apple iOS soon"

"FloodWatch" app utilizes advanced technologies such as satellite data analysis, mathematical modelling, and real-time monitoring to deliver accurate and timely flood forecasts. With this app, users can access essential information regarding flood situation in the country. The user-friendly interface will make it easy for anyone to stay informed and minimise risk during flood events.
